

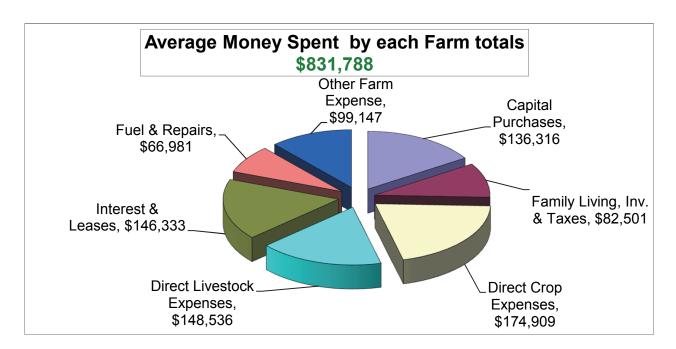

Brief Overview of 2017 in Production Agriculture

Farm Business Management Program Database

Minnesota farmers experienced their fifth consecutive year of low profitability in 2017. This is one of the key findings in the annual report devloped by the Minnesota State farm business management education program in cooperation with the University of Minnesota. The analysis used data from 2,164 participants in the Minnesota State farm business management education database. Participating producers represent approximately 10 percent of commercial farmers in Minnesota.

The median farm earned \$26,556, up slightly from just over \$25,654 in 2016. Declines in farm income were largely driven by low profits and losses for cash crop farms, while livestock farms, in general, had a better year. With average investment just under \$3 million, farms earned a 2.2% return on investment. Across all farms types, almost one third of farms lost net worth in 2017.

For the third consecutive year, Minnesota farmers produced bumper crops of Minnesota's primary cash crops, corn and soybeans. Similar to the two previous years, high yields did not produce high profits. The median crop farm earned \$21,920, down from \$43,705 in 2016.

Profits were up slightly for each of Minnesota's major types of livestock operations: dairy, pork and beef. The median livestock producer earned only \$47,902 from farm operations for the year. Hog producers had a big turn-around, after many lost money on pig production in 2017. For dairy and beef producers, however, profits remained at low levels by historical standards.

Most Minnesota farmers are still in reasonably good shape financially, even after five years of low earnings. The average farm's debt to asset ratio at 46%, an increase of 1 percent from 2016. Working capital has declined from 2012 to now, which is at a 5 year low of \$192,178.

What is Net Farm Income used for?

Net Farm Income dollars are used to pay for Family Living, Social Security and Income Tax, Retirement Accounts, Medical and Health expenses, and loan principle payments. The list below shows the data for the current year. A positive balance indicates that there is revenue available for other uses, while a negative balance indicates there is a need for revenue from other sources.
